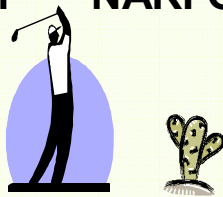

## EMBEZZLEMENT ALERT

To avoid the pain and agony on an embezzlement, take these simple precautions:

1. Have bank statements sent to your home. Open them and review the checks for any discrepancy.
2. Sign checks personally and ask that all back-up information be attached to the check for you to review if you desire.
3. Sign-off on the back-up information so that the same information cannot be presented to you twice.
4. Review bank deposits to make sure all checks are being deposited.
5. Review the outstanding check list on the bank reconciliation to make sure the bookkeeper is not holding checks *back*.
6. *Review and challenge job cost reports regularly.*
